INSTRUCTIONS TO THE APPLICANTS TO B.Sc NURSING COURSE UNDER THE N.R.I. CATEGORY SEATS

General information

- The prospectus for NRI seats 2021-2022, in Lourdes College of Nursing Ernakulam, provides
 the general information and rules relating to the selection and admission under NRI quota for the
 B.Sc. Nursing degree course. Application for admission to B.Sc. Nursing (Academic year 202122) in the NRI category at this college is being invited on the basis of this prospectus.
- ii. The candidates seeking admission to B.Sc. Nursing course under NRI quota are also advised togo through the AMCSFNCK prospectus 2021-22 (available at: www.amcsfnck.com) and acquaint themselves with the relevant information relating to the B.Sc Nursing course.
- iii. NRI category seats, available for B.Sc. Nursing degree course 2021-2022, are **Ten (10)**.
- iv. Details of the admission 2021-22 under NRI quota are also available on the website of the Lourdes College of Nursing: www.lourdescollegeofnursing.in.
- v. Online application form is available from 18-08-2021 onwards at: www.lourdescollegeofnursing.in.

Academic Eligibility

- As per the Indian Nursing Council norms, the candidates should have passed +2 course under the 10+2 school system with 50% aggregate in Physics, Chemistry, Biology & English.
- As per norms of Kerala University of Health Sciences (KUHS), for admission to B.Sc Nursing, the minimum educational requirements shall be the passing of: Higher Secondary School Certificate Examination (12 years course); or Senior School Certificate Examination (10+2); Pre-Degree Examination (10+2); or an equivalent of 12 years schooling from a recognized Board or University with Science (Physics, Chemistry, Biology) and English with a minimum of 50% aggregate marks.

Eligibility for admission to N.R.I. Category Seats

- The eligible candidates for NRI category admission must have passed the Higher Secondary Examination of the Board of Higher Secondary Education of Kerala or equivalent examinations recognized by any of the Universities in the State of Kerala with an aggregate greater than or equal to 85% marks in Physics, Chemistry, Biology and English in the second year.
- The applicant for a NRI seat should have 17 years of age as on 31 December 2021 (the date of birth being shown on the Matriculation or equivalent certificate). No relaxation of age will be allowed.
- The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and s/he must prove it with relevant documents.
- According to the GO (MS) No.243/2014/H&FWD dated 06.08.2014, an applicant who depends
 upon (Blood relatives) his/her Father/Mother/brothers and sisters (inclusive of first cousins)
 Husband/Wife/Brothers and Sisters (inclusive of first cousins) of Father or Mother/Half
 Brother/Half Sister/Adopted Father or Adopted Mother working abroad will only be eligible to get
 admitted in the NRI category seats.

Fee Structure for N.R.I. Category Seats

The Admission and Fee Regulatory Committee for Medical Education in Kerala (AFRC) by its Order (No. AFRC50/18/B.Sc (N)/PB B.Sc (N)) dated 10.5.2018, has fixed the Tuition Fee for NRI seats to B.Sc Nursing degree course 2021-22 is given below. The other items in the fee structure are fixed asper the order AFRC50/18/B.Sc (N)/PB B.Sc (N)/M.Sc (N) dated 20.4.2018.

Accordingly, a selected applicant in the NRI category is liable to pay the following fees:

Apart from the schedule of fees given above, the selected candidates are required to remit a proportionate administration/affiliation and examination fee to the University and also the Community Health Nursing PHC/CHC fee, and PTA & SNA fee related to co-curricular activities. Hostel & student's dividing system (food expenses) will be charged separately.

Application process

- Application for NRI seats shall be submitted **ONLINE** through a single application on the Website of Lourdes College of Nursing Ernakulam (www.lourdescollegeofnursing.in.)
- All candidates shall pay an application fee of Rs.2000/- remitted online.
- The Application fee once remitted is non-refundable, under any circumstances.

The scanned copy of the following documents shall be uploaded with the application form:

- 1 School Leaving Certificate (S.S.L.C.) of students, to establish that they have completed 17 years of age as on 31-12-2021.
- 2 Plus Two or equivalent examination mark-sheet/pass certificate.
- A statement to show that the high school in which the student completed the course, has been accredited by the State/Country/University (if applicable).
- 4 Affix in the application form, the signature of the student and the parent/guardian.
- 5 An Equivalence Certificate from the Association of Indian Universities (if applicable).
- 6 An Eligibility Certificate from Kerala University of Health Sciences (if applicable).
- 7 Sponsorship Certificate: A self affidavit/declaration (*find specimen format in Annexure-1*) by the NRI relative
- 8 Copy of the Overseas Employment Certificate issued by the employer, attested by the Embassy OR if self-employed, a statement in this regard that is duly attested by the Embassy.
- 9 The attested copy of the relevant page of the passport where Employment Visa is stamped and if it is not submitted the employment certificate duly attested by the Indian /Embassy or Consulate
- 10 Relationship Certificate to be issued by the Revenue Authorities to prove the relationship between the candidate & the NRI relative as per GO (MS) No.243/2014/H&FWD dated 06.08.2014 (*Thahsildar | Vii*lage officer)

Submission of applications

- The last date for the online submission of application is 30 September 2021.
- The date for the selection interview and admission is **27 October 2021**.

Eligibility for Admission

- Admission to NRI seats in B.Sc. Nursing will be from the rank list prepared on the basis of the aggregate of $\geq 85\%$ marks in Physics, Chemistry, Biology and English in the second year.
- The candidate must present himself/herself with all the originals of the required documents on the day of the certificate verification.
- In case a tie with regard to the total marks in Physics, Chemistry, Biology, and English in the second year occurs, the marks in Biology shall be considered for preference. If a tie in the marks still occurs, Chemistry and Physics will be considered. If a tie still exists, the age of the candidate will be taken into account, the elder getting preference over the younger.
- The selection/waiting list of candidates will be intimated through SMS to the registered mobile number as well as by e-mail to the personal e-mail ID furnished to us. The selection/wait list will also be published on the college Website.
- The Published merit list will be valid till the cutoff date declared by the statutory bodies for admission to academic year 2021-2022.
- The management will admit only those students who have complied with all the instructions and according to the information for admission, furnished in the 'LCN Prospectus for NRI seats 2021-2022.'

Original documents to be submitted at the time of interview and admission

- 1. Relationship Certificate issued by the Revenue Authorities to prove the relationship between the candidate & the NRI relative as per GO (MS) No.243/2014/H&FWD dated 06.08.2014 (*Thahsildar* /Village officer)
- 2. Copy of the Overseas Employment Certificate issued by the employer, attested by the Embassy OR if self-employed, a statement in this regard that is duly attested by the Embassy.
- 3. The attested copy of the relevant page of the Passport where Employment Visa is stamped and if it is not submitted the employment certificate duly attested by the Indian /Embassy or Consulate.
- 4. A self affidavit/declaration by the NRI relative (Sponsorship Certificate: Annexure-1)
- 5. Certificates issued by a Scheduled Bank stating that s/he is a Non Resident Indian holding NRI account other than a Zero balance account
- 6. The relevant page of the SSLC book/equivalent board certificate as proof of age and date of birth.
- 7. Certificate and Mark list of qualifying examination (Plus Two/12 Std.) or printout of the result sheet from the Website.
- 8. Eligibility/Equivalency certificate from Kerala University of Health Sciences/Directorate of HSC, Kerala, wherever applicable.
- 9. A Conduct Certificate from the institution last attended (preferably issued within six months)
- 10. Transfer Certificate (T.C)
- 11. Migration Certificate, if applicable
- 12. Nativity Certificate
- 13. Conduct Certificate from the Head of Institution last studied in proof of clause (Prohibition of Ragging) of the prospectus.
- 14. Copy of the Photo ID Proof (Aadhar / Voters ID/Passport)
- 15. Passport size photographs (3Nos)
- 16. Additionally, two sets of photocopies of all the certificates/documents attested by Gazatted officers.
- 17. A Certificate of Medical Fitness from an authorized Medical Officer with MBBS.
- 18. Two hard copies of the submitted online application form

Conversion of NRI seats to open merits under management quota

• Unfilled seats if any under the NRI quota will be reverted to the open merits under the ManagementQuota.

Remittance of Fee

- The candidates selected under the NRI category are required to remit the prescribed fee and deposit for the first year of the course, within the duration of four days of selection, by way of DD, Cheque, RTGS and NEFT. The fee has to be paid through the sponsor's NRI account in India.
- If any selected candidate fails to complete the admission procedure under the NRI seats within four days, those candidates will be considered as "declined" joining the B.Sc (N) course 2021-2022.
- In the above circumstances, the vacant seats will be filled by the candidates on the waiting list or by new applicants.

Discontinuation of the course

If any candidate discontinues the course, after closing of admission as notified by the statutory authority, the candidate has to pay the full fee of the remaining course (4 years). The collection of liquidated damages shall be as per the final decision of the AFRC or Court of Law.

Other information

- 1. Ragging is strictly prohibited. If it is found during the admission or at any time thereafter, that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the Institution. Whoever commits, participate in, abets or propagate ragging within or outside the institution shall be suspended from the institution with immediate effect and the Principal shall report the matter to the civil/police authorities.
- 2. Without prejudice to the directions of the Nursing Councils/Government/University, the decision of the management of Lourdes College of Nursing Ernakulam shall be final on all matters regardigto the admission.
- 3. In view of thorough academics, round-the-clock study facilitation and mentoring, B.Sc. Nursing degree course in Lourdes College of Nursing Ernakulam is a residential collegiate education system.
- **4.** Every student is required to adhere strictly to the Code of Conduct of the college.
- 5. All candidates who get selected should get themselves vaccinated against Hepatitis before admission. A certificate to the effect shall be produced at the time of admission or before commencement of the course.
